Leeds-Grenville Safe Communities Coalition sounds alarm on protecting the deaf

For those who are deaf or hard of hearing the ongoing pursuit of Bill 148, the Visual Fire Alarm Systems Act, is literally an issue of life or death. The private members bill, introduced in February 2009 by former Pickering-Scarborough MPP Wayne Arthurs aims to require that all new provincial and municipal public buildings be equipped with visual fire alarm systems. While Arthurs' bill is a good start, officials from the local chapter of the Canadian Hearing Society say that it is not enough. Currently the lack of legislation allows landlords to install nothing more than an audible smoke alarm. Those residents who are hearing impaired and require assistive devices such as flashing lights and a bedseek out the equipment, which ranges from \$100 to \$1,500 in price, and purchase it for themselves. The frustration within the deaf/hard-ofhearing community was brought to the attention of Brockville's Chief Fire Prevention Officer, Randy Burke, last winter after he received a number of complaints from people across Leeds and Grenville. Burke and the CHS have since joined forces with the Leeds and Grenville Safe Communities Coalition in an attempt to mitigate the problem locally and raise the issue provincially.

The first steps were made toward this effort last Thursday afternoon at a news conference held by the SCC in Brockville, where the Coalition announced the launch of a voluntary registration

shaker are encouraged to form for the deaf, deafened or hard of hearing. The form, explained CHS regional program manager Anna Strati-Morrison through interpreter Kym Watson, will allow fire dispatchers to be aware if a deaf person lives at a home where a fire is reported.

> Strati-Morrison continued that the local effort is the first-ever presented to the hearing society and she is encouraged by the co-operation of the partners involved and the initial positive reaction from the Ontario Fire Marshal's Office.

"The work taking place with this initiative is unprecedented," said SCC co-chair, David Dargie, adding that the initiative has generated interest from the Canadian office of the Safe Communities Coalition and that according to former Brockville


